Step 2: "We came to believe that a Power greater than ourselves could restore us to sanity."



Tradition of the Month

Tradition 2: "For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants, they do not govern."

There is a big difference between group conscience and group opinion. The democracy of the group might be in danger of being dictated by personalities and the popularity of a few outspoken members. To invite a loving God to represent the ultimate authority of the group, we recite **The Serenity Prayer** to begin our group conscious meetings as a way to set the tone. It helps put the group in the right frame of mind before beginning the group conscious meetings where we discuss the business of the group and make decisions. When we collectively ask God to guide us prior to discussing the business of the group, we are more likely to practice unity and trust the outcome of group decisions.
